The future landscape of mental healthcare is being shaped by the current renaissance of research showcasing the efficacy of psychedelics in treating various mental health disorders. Occupational therapy's unique skillset for promoting holistic health and well-being can align with the evolving needs for qualified mental health professionals to deliver psychedelic-assisted therapies. Occupational Therapy in Program Development: Advocating for Cognition Inclusion for In-Home Support Services Evaluations

Lea Le, MS, OTR/L

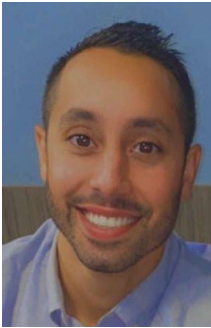
Advocacy is an everyday practice for occupational therapy practitioners and can be used to identify gaps and develop new programs. This session will explore how a nonprofit agency noticed gaps with in-home support services (IHSS) and created its own program to address it. By including occupational therapy practitioners in the contract, it allowed for funding for a comprehensive evaluation that also includes cognitive assessment, something that was previously omitted in other resources and services. Through the program, occupational therapy practitioners utilized assessments to advocate for IHSS for individuals living in permanent supportive housing who have a history of chronic homelessness, experience mental health conditions, cognitive challenges, and physical health issues. The additional support has helped individuals avoid evictions, maintain housing, and live independently in the community.

About Our Presenters



Jawad Aqil, OTD, OTR/L, earned their bachelor’s degree in kinesiology in 2017 from California State University, San Marcos, and is a candidate for Doctor of Occupational Therapy at the University of St. Augustine for Health Sciences. They have prior experience in acute mental health, community mental, and pediatrics. Current professional interests are in mental health, entrepreneurship, home health, academia, and advocacy.



Christy Billock, PhD, OTR/L, DipACLM, previously worked at the Keck Graduate Institute as a professor and founding program director. She has also served as a professor and curriculum coordinator of occupational therapy at West Coast University and was an associate professor at Loma Linda University. She has a PhD in occupational science from the University of Southern California, where her dissertation focused on women’s experience of spirituality in everyday life. She created the Occupational Therapy Spiritual Narrative Assessment (OTSNA) tool. Billock has taught occupational therapy for 23 years in a broad range of subject areas including neuroscience, lifestyle medicine, geriatrics, rehabilitation, mental health, wellness, and occupational therapy history and theory. Her clinical background is in inpatient rehabilitation. She is passionate about innovation in occupational therapy and growing the profession’s role in prevention and wellness.



Jessica De Brun, OTD, OTR/L, is an assistant professor of occupational therapy at the University of St. Augustine for Health Sciences, San Marcos, CA. De Brun completed her BS, MOT, and post-professional OTD at Loma Linda University. She has a wide variety of experience as a mental health occupational therapy practitioner working in emerging practice, community-based pediatric, and adult mental health services. De Brun’s clinical practice experience includes pediatric trauma intervention centers, domestic violence shelters, substance use and recovery services, local school districts, and regional centers. Her research and scholarly interests have focused on emerging practice, program development, trauma-informed education, secondary trauma and burnout, early childhood trauma, the maternal-child co-occupational experience, and occupational justice. She has served as a fieldwork educator in various emerging practice and community-based settings including mental health programming for children, survivors of domestic violence, and for individuals with co-occurring mental health and substance use disorders. De Brun serves as chair of the Occupational Therapy Association of California’s (OTAC) Nominations Committee, where she advocates for OT leadership in California and for the occupational therapy profession.



Praveen Injeti, OTD, OTR/L, MFT, has been an occupational therapy practitioner since 1999 and has worked in various settings that have empowered his growth as a clinician. He received his education as an occupational therapy practitioner at Loma Linda University, going on to obtain a Master of Art in psychology with a focus in marriage and family therapy and an OTD. Injeti has been an adjunct

faculty since 2007 and recently transitioned to a full-time faculty as an assistant professor for Loma Linda University's Department of Occupational Therapy. His specialty area is mental health. Injeti also plays the role of a faculty consultant; helping students with research projects, assisting with capstone curriculum and program development. As a practitioner his experiences range from long-term care to the jail system treating psychiatric patients, to in-patient behavioral health settings as well as home health. He currently works in an in-patient behavioral hospital as an occupational therapy practitioner where his duties are providing clinical care for the pediatric population. He has had the privilege to present at OTAC and guest lecturer for other programs and disciplines.



Lea Le, MS, OTR/L, graduated from San Jose State University with a master's in occupational therapy. She is currently an Occupational Therapist at the Mental Health Association of San Mateo County, a non-profit organization that provides community-based mental health

services. She works with individuals who have experienced chronic homelessness and live with mental and physical health conditions to increase participation in occupations, with the goal of community integration and housing maintenance. Her interests include mentoring students and has been a lecturer for the occupational therapy program at San Jose State University, as well as a Fieldwork Educator for Fieldwork I and II students. She is also passionate about advocacy and currently a member of the OTAC Advocacy and Government Affairs Committee.



Ingrid Leu, OTD, OTR/L, is currently the director of occupational therapy at Exodus Recovery, which provides psychiatric treatment services in hospital-based inpatient and outpatient programs in Los Angeles County. She supervises Level I and Level II students from different

universities to increase exposure and pique interest in mental health. Leu also co-founded the Greater Los Angeles Mental Health Practice Network, whose goal is to provide education and support mental health occupational therapy practitioners while advocating for occupational therapy's distinct role in mental health practice. Leu is also currently teaching at Stanbridge University.



Erin McIntyre, OTD, OTR/L, is an assistant professor of occupational therapy at the University of St. Augustine for Health Sciences. Her scholarly interests include psychosis, trauma informed pedagogy, community mental health and role emerging fieldwork

education. She represents OTAC with the California Coalition for Mental Health.



Christine Villalobos, OTS, was raised in a working-class neighborhood in Los Angeles. She is a former early childhood teacher, sister to an autistic adult who loves snacks as much as I do, and daughter of a hemorrhagic stroke survivor. Her residency experience at DWC working with unhoused neighbors has helped show the

connection between political economy and social determinants of health and its effect on mental health and well-being of every person in our world. As a future occupational therapist in the unhoused sector, she hopes to challenge the systems that brought individuals into becoming unhoused in the first place and provide trauma

informed care to support those transitioning from unhoused to housed. Villalobos believes that OT can be a means by which society expands the definition of health to include both the physical and mental components.
